## Proposed By-Law Change #1

### ARTICLE III – MEMBERSHIP

Purpose: House Cleaning – combine #2 and #3 so that it will read “Contributor/Dealer”

A. Any Snowmobile Club within the State of New Hampshire, duly organized and incorporated with compatible intents and purposes, is eligible for membership, upon acceptance of its By-Laws by the Board of Directors.

B. Membership Category

1. Club Affiliated Membership
  - a. Single membership, 18 years of age and older.
  - b. Family membership, including children under 18 years of age.
  - c. Junior membership, from the age of 12 years to the age of 18 years old.

~~2. Any Dealer having an interest in furthering the sport of snowmobiling is eligible for membership.~~

~~3. Contributing membership will be open to any business or organization having an interest in furthering the sport of snowmobiling.~~

*2. A Contributor/Dealer membership will be open to any business or organization having an interest in furthering the sport of snowmobiling.*

## Proposed By-Law Change #4

### ARTICLE IV – ORGANIZATION / C. EXECUTIVE OFFICERS continued:

Purpose: House Cleaning – from By-Law #1 change

- D. BOARD OF DIRECTORS - The Board of Directors shall consist of the Executive Officers and twelve (12) Directors: one for each county (10); one Contributor (any business or organization having an interest in furthering the sport of snowmobiling); and one Dealer (any dealer having an interest in furthering the sport of snowmobiling).

Should Read:

- D. BOARD OF DIRECTORS - The Board of Directors shall consist of the Executive Officers and *eleven (11) Directors*: one for each county (10); and *one Contributor/ Dealer Director*

## Proposed By-Law Change #5

### ARTICLE IV – ORGANIZATION / D. BOARD OF DIRECTORS continued:

Purpose:

1. COUNTY DIRECTOR

- a. Each County Director shall be a resident of the state of New Hampshire, a member of a club within the county he represents and the club shall be a member of the New Hampshire Snowmobile Association. County directors shall be elected by members from their respective counties for a two-year term at a county meeting held no later than thirty (30) days prior to the Annual Meeting of the New Hampshire Snowmobile Association. Directors will be elected every 2 years.

1. COUNTY DIRECTOR

- a. County directors shall be elected by members from their respective counties for a two-year term at a county meeting held no later than thirty (30) days prior to the Annual Meeting of the New Hampshire Snowmobile Association. ## Proposed By-Law Change #2

### ARTICLE IV – ORGANIZATION

Purpose: to add the following “ in good standing”

Note: When circumstances dictate, any wording that applies to male may be substituted to apply to female.

GENERAL - The Association shall be governed by a Board of Directors. Executive Officers upon election shall be members of the Board of Directors. It shall be the duty of the Board of Directors to carry out the wishes of the majority of the Membership. All Board of Directors members shall be members of the New Hampshire Snowmobile Association.

### ARTICLE IV – ORGANIZATION / B. DUTIES continued:

Purpose: House Cleaning – from By-Law #1 change

6. Each Dealer and Contributing Director shall communicate with his respective segment at least twice a year.

## Proposed By-Law Change #6

### ARTICLE IV – ORGANIZATION

#### D. BOARD OF DIRECTORS / 1. County Director continued:

Purpose: House Cleaning

2. OTHER DIRECTORS - Shall be elected by the delegates at the Annual Meeting from a slate of candidates presented by the nominating committee.

- a. The Dealer Director shall serve a two (2) year term. They will be elected every two (2) years in even years. The Contributor Director shall serve a two (2) year term. They will be elected every two (2) years in odd years.

Should Read:

- a. *The Contributor/Dealer Director shall serve a two (2) year term. They shall be a member in good standing in the NHSA. They will be elected every two (2) years in even years.*

- c. Assistant Directors shall be voted or selected by the County Director or the respective County. The Assistant’s term shall run concurrent with the Directors term.

Should Read:

- c. Assistant Directors shall be voted or selected by the County Director or the respective County. *They shall be a member in good standing in the NHSA.* The Assistant’s term shall run concurrent with the Directors term.
